**District 1, Wards 1, 8, 10, and 11:** The total number of votes cast for Village President, Dean Wolter, in District 1 was 1642 votes.

**District 2, Wards 2, 5, 6 and 7:** The total number of votes cast for Village President, Dean Wolter, in District 2 was 1359 votes.

**District 3, Wards 3, 4, 9, 16 and 17:** The total number of votes cast for Village President, Dean Wolter, in District 3 was 1590 votes.

**District 4, Wards 12, 13, 14 and 15:** The total number of votes cast for Village President, Dean Wolter, in District 4 was 1693 votes.

The Municipal Board of Canvassers Summary Statement and Certification declared the following person as receiving the greatest number of votes for Village President in the Village of Germantown on April 5, 2016:
