2020 Senior Center Budget – Mark reported that the Finance Department distributed the 2020 Budget materials this week. The deadline for turning in budget proposals is August 26th. Mark mentioned the projects that have been completed at the center the last three years (2017- gift shop remodel, 2018 – Senior Van, and 2019 – interior flooring and painting of the center). Staff anticipates that the 2020 Building and Grounds Budget request will include monies for materials and labor to replace of the exterior brick on the front of the center. - Firemen's Park Shelter Project – Mark reported that the village engineering department is completing final design of the project utilities. Soil borings are scheduled for early August for the water and sewer routes, as well as the building site. Phase 1 of the project (sewer/water, pathways, lighting and electrical service) is planned for public bidding the end of August.
- Summer Music Concerts – Mark handed out the schedule of remaining concerts for the Community Band on Wednesday nights, and the Music at the Pavilion Series on Thursday nights.
