 - k. The Club will be doing the Easter Bunny event again this year, last year the center did the event with the club paying for it due to covid. 2021 Senior Center Budget – Patti reported that the 2022 Senior Center Budget was presented to the Village Board at the Committee of the Whole Budget Meeting on October 6th. The Senior Center Operating Budget for 2021 stands at \$120,222 with projected revenues of \$39,600. At the November 1st meeting, the Village Board approved sending forth the 2022 Budget for Public Hearing on November 15th. No modifications have been made to the submitted 2022 Senior Center Budget.

Park and Recreation Department Director - Patti reported that our new director wis Guiford "Gil" Standridge and he will be starting on Monday, October 25th. He served as outdoor recreation manager for Hot Springs Village in Arkansas since 2019, recreation programs manager for city of Little Rock from 2013 – 2019, camps and conferences coordinator at Winona State University from 2007-2008, associate director of recreational and intramural sports at University of Arkansas Fayetteville from 2004-2007 and assistant director of student activities and centers at UW-LaCrosse from 1997-2004.
