

**VILLAGE OF GERMANTOWN
BOARD OF CANVASSERS
MEETING MINUTES
April 7, 2014**

CALL: The meeting was called to order at 8:30 a.m. by Village Clerk Goeckner.

ROLL CALL: Members Arline Flesch, Lynn Grgich and Village Clerk Barbara Goeckner. Also present Deputy Clerks Christine Micka and Timmerly Tamborino.

PROCESS AND COUNT LATE-ARRIVING ABSENTEE BALLOTS: The Board of Canvassers processed the late-arriving absentee ballots received for the Spring Election held on April 1, 2014 in the Village of Germantown.

District 1, Wards 1, 8, 10, and 11: There were no late-arriving absentee ballots received in District 1. The certification Statement of Municipal Board of Canvass was completed and signed by the Board of Canvass members.

District 2, Wards 2, 5, 6 and 7: There were three late-arriving absentee ballots received in District 2. One ballot was rejected, and two were counted and given voter numbers LA226 and LA227.

No votes were recorded on the tally sheet.

Ballots were sealed in a ballot bag, seal number Z584136 was recorded, and signed by Board of Canvass members. The certification Statement of Municipal Board of Canvass was completed and signed by the Board of Canvass members.

District 3, Wards 3, 4, 9, 16 and 17: There were two late-arriving absentee ballots received in District 3 and both ballots were rejected. The certification Statement of Municipal Board of Canvass was completed and signed by the Board of Canvass members.

District 4, Wards 12, 13, 14 and 15: There were two late-arriving absentee ballots received in District 4, which were given voter numbers LA1076 and LA1077. Voter number was recorded on absentee log and in poll book.

The following votes were recorded on the tally sheet:

Jeff Hughes received 1 vote for District 4 Trustee.

Ballots were sealed in a ballot bag, seal number J039680 was recorded, and signed by Board of Canvass members. The certification Statement of Municipal Board of Canvass was completed and signed by the Board of Canvass members.

CANVASS OF 2014 SPRING ELECTION - MUNICIPAL RESULTS: The Board of Canvassers reviewed the results for the Spring Election held on April 1, 2014 in the Village of Germantown.

District 1, Wards 1, 8, 10, and 11: The total number of votes cast for Village Trustee in District 1 was 169 votes, of which:

David Baum received 166 votes
Scatterings received 3 votes

District 2, Wards 2, 5, 6 and 7: The total number of votes cast for Village Trustee in District 2 was 188 votes, of which:

Jeff Werderman received 185 votes
Scatterings received 3 votes

District 3, Wards 3, 4, 9, 16 and 17: The total number of votes cast for Village Trustee in District 3 was 432 votes, of which:

Bob Warren received 250 votes
Dennis Myers received 180 votes
Scatterings received 2 votes

District 4, Wards 12, 13, 14 and 15: The total number of votes cast for Village Trustee in District 4 was 182 votes, of which:

Jeff Hughes received 178 votes
Scatterings received 4 votes

The Municipal Board of Canvassers Summary Statement and Certification declared the following persons as receiving the greatest number of votes for Village Trustee in the Village of Germantown on April 1, 2014:

District 1 Trustee – David Baum
District 2 Trustee – Jeff Werderman
District 3 Trustee – Bob Warren
District 4 – Jeff Hughes
